## An Award-Winning Duo

BHEA selects Instructional Assistants Unit President Carol Courneya and Certificated Bargaining Team member Chris Bushée to be honored at the 2016 CTA Bay Valley WHO (We Honor Ours) Awards

They both started their BHUSD careers in 1997. They both decided early on to take a more active role in BHEA. They both became involved in their bargaining and grievance committees. They both became vice-president and later president of their unit and on April 25th, both Carol Courneya (HS) and Chris Bushée (HS) will be honored by CTA at the WHO Awards Ceremony at the Universal Sheraton Hotel in Universal City.

Carol Courneya was selected by BHEA to receive the Local WHO Award in recognition of her tireless advocacy and efforts towards helping her fellow educators. "Carol goes above and beyond the call of duty in both her position as a special education instructional assistant and as IA president," said BHEA President Telly Tse.

Chris Bushée was nominated for the State WHO Award for his contributions at the local, state, and national level. Although his last term as BHEA president ended in 2010, he has remained active in BHEA by serving at the local level as Grievance and Political Action Committee Chair, bargaining team member, and site representative. At the CTA level, Chris serves as a member of the ABC (Association for Better Citizenship) Committee and the State Council of Education. He served as BHEA President from 2005 to 2010 and won the Local WHO Award in 2011 and the Service Center WHO Award in 2015.

A general education teacher required to be in IEP, 504, and SST meetings more than 120 minutes a month may request release time in amounts corresponding to the additional meeting time above 120 minutes. (Article IV, Section 1, No. 4a, Appendix C).

#### **Certificated Bargaining**

The bargaining team met with the district on March 10th and reached a conceptual agreement in the areas of Class Size and Permits. The team is still working on terms regarding substitute teacher language and the 2017-18 and 2018-19 school calendars. Details of the conceptual agreement will be revealed as language is developed. #### **Bylaws**

At the March 10th Rep Council meeting, changes to the BHEA Bylaws were unanimously approved. include Changes reimbursement for the Grievance and Bargaining Chairs, a stipend increase for the position of IA President and Treasurer, a stipend decrease for the position of Secretary, procedures for simultaneous vacancies in the president and vice president positions, and the moving of the succession date for BHEA officers from June 30th to June 16th during an election year.
